*MAP Policies

1) Retail vs. Online MAP

Organifi MAP policy sets minimum pricing for both physical retail and online sales channels. MAP for each channel is differentiated based on specific implications of selling in retail and online.

2) Customers with both Retail & Online Channels

Separate retail and online MAP policies must be followed by customers who have both physical retail and online components to their business. Therefore retail MAP cannot be applied to a retailer's online channel, since online MAP applies in this scenario.

3) MAP Violations

MAP violators will be given one courtesy notice to immediately become compliant. A second MAP violation will result in customer being prohibited from selling Organifi, with necessary steps taken to enforce this restriction.

4) MAP Exceptions

MAP retail exceptions may be granted for EDLP programs or as specifically approved at selected retailers on a case by case basis. Such MAP exceptions must be discussed with Organifi's sales team with written pre-approval.
